

Form T1 - TEACHING AND COURSE EVALUATION FORM

The Council of Deans of March 19th, 2014 has validated the change of the questionnaire of the T1 starting the upcoming Spring 2014. The form consists of four main areas (course and content; instructor; methodology; student). One extra heading has been considered for lab courses only (security). All statements included in this form can be answered by all students in all courses, thus eliminating the need for a N/A option.

Courses covered : The T1 survey is only evaluating courses of the following types : Regular, Lecture, Studio, Lab, and Workshop. The T1 survey is NOT evaluating courses of the following types : Senior Project, Research project, Thesis, Practicum, and Internship.

Confidentiality of the responses: To ensure the confidentiality of the student feedback all T1 reports with equal or less than 5 students (Tutorial and Low Enrollment sections) will not be disclosed to the Instructor, but will instead be made available to the Dean, and Chairperson and will be kept in his file for renewal and promotion. This disclosure measure has no impact on the calculation of the Instructor Composite Score for the TSR report.

Low response ratio : To ensure the relevance of the T1 Report, the Council of Deans has defined a response ratio based on the T1 ad-hoc Committee report. If a response ratio fall short of the threshold, the T1 report will not be disclosed to the Instructor, but will instead be made available to the Dean, and Chairperson. The result of this course will not be included in the calculation of the Instructor Composite Score for the TSR report.

The Instructor may request from the Chairperson a summary of undisclosed T1 Report.

The purpose of the T1 form is to assess students' perception of the quality of their educational experience at NDU, in particular, their perception of course and delivery effectiveness vis-à-vis their self-profile. The T1 form is to be used as one of many tools to evaluate course and delivery effectiveness.
