Biography

Georges is an associate professor of economics at NDU. His research is chiefly applied, using panel data econometrics. The main focus of his research has been the Arab world trade and the growth determinants in the Middle East and North Africa (MENA) region.

Georges has also served as a consultant for the Economist Intelligence Unit, and the United Nations Economic and Social Commission for Western Asia (ESCWA).

Currently, he is working on panel econometrics techniques accounting for cross-sectional dependence and applying those techniques using gravity/origin-destination interaction models.

Georges holds a "doctorat" in Economics from Sciences Po Paris. He also holds a "Diplôme d'Etudes Approfondies" in International Economics from Sciences Po Paris as well as a Master of Science in Econometrics from the University of Nottingham.
