## Biography

Eugene Richard Sensenig is a professor in the Faculty of Law and Political Science (FLPS) and the co-founder of the 'Lebanese Emigration Research Center (LERC)' and 'Gender, Communications and Global Mobility' (GCGM) studies unit at FLPS. He has an MA in German literature and a PhD in political science from the Paris Lodron University of Salzburg (PLUS) - Austria. Following his PhD, Prof. Sensenig worked on his habilitation research in German, titled: "From Metternich to EU Accession – 150 Years of Austrian Migration Policy". He co-founded the 'GenderLink Diversity Centre', a social enterprise in Salzburg working with European governments, business and civil society. He has published five books and over 100 scholarly articles in the fields of migration, natural resources development, diversity, equity and inclusion (DEI), transportation reform, gender, minority studies, interfaith dialogue and Central European Orientalism. He is also responsible at FLPS for strategic planning in the fields of the Catholic Social Teaching (CST), sustainability, and the political economy of coexistence.
